## **Continuity of Business**

- Permit requests when Control Areas established
- Initially just commercial premises
- Later permitted movement of backyard birds to slaughter and eggs for distribution
- Permits needed to move into a Control Area





### **Commercial Premises in Control Zones**



# Using EMRS2 for permitting

- To use EMRS2, all locations need a Prem ID
- To generate permits from EMRS2 need trained staff
- Permit requires approval at both ends of permit in EMRS
- Template used to merge data from EMRS2 into a permit document

Conditions	
1	Poults will be moved in clean reusable or new paper boxes with clean reusable or new pads.
2	Trucks and trailers will be cleaned and disinfected before poults are loaded.
3	Prior to coming onto the hatchery premises and or backing into the loading dock, the wheels and undercarriage with be sprayed with disinfectant.
4	Truck drivers must use full coverage on each farm of delivery (hairnet, mask, coveralls, gloves, and disposable boot covers) and follow protocols for movement between the farm and truck.
5	Floor mats, pedals, seat, and shoes must be sprayed with disinfectant and tires and undercarriage disinfected before leaving the farm.

### **MN Permitting Stats**

- Hours worked
  - 288 staff hours/week
- Total Permits
  - Poultry and eggs 931 permits / 3,074
    movements
  - Feed: 553 permits / 5,587 movements
  - Slaughter product: 1,399 permits /4,628 movements



### 4-State Permitting Survey

- Permitting done by state or state led staff
  - WI turned all permitting over to HPAI unit
- All permit information went into EMRS2 but after the permit generated for IA and SD
- Core poultry products permitted
  - Other permits varied between states
